You can reach the venue by:

Air

There are two International Airports in Goa.

1. Dabolim Airport (GOI)- 36 km (60 mins approx.)
2. Manohar International Airport (GOX)- 39 Km (60 mins approx.)

Prepaid cabs are available at the airport. The Mercure Goa Devaaya Resort also provides airport pick-up and drop service. A direct request can be made to the Resort.

Depending on the airport and the type of vehicle that you are hiring, the pre-paid fare usually costs between- INR 1500 - 2000.

If you hire the car from the hotel, the price will be informed by the hotel itself.

Money Conversion

There are currency exchange counters at the Airport. Money exchange counters by EBIX Cash at 03 locations (International Arrival Immigration area, Arrivals Concourse & Pre-Security check area).

The Airport in Goa also has major bank ATM'S which accept the VISA, MASTERCARD and other Currency Logo.

People can exchange their money in Dabolim airport or nearest bank branch of the state bank of India, ICICI, Axis and HDFC.

Rail

Vasco Da Gama Railway station – 38 Km (55 min approx.) 2. Madgaon Railway Station- 46 km (65 min approx.)

Ferry Service

The ferry to reach Divar Island is available from 3 ferry points depending on which part of Goa you are arriving from

1. Old Goa Ferry Point
2. Naroa Ferry Point
3. Ribandar Ferry point

The ferry service to cross the Island is functional 24/7.

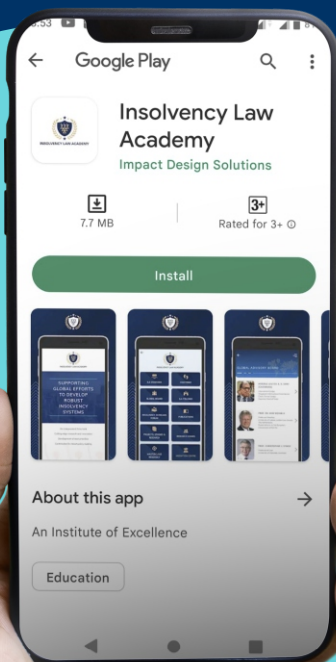
