#### Introduction – What does my participation involve?

## What is the purpose of this research?

The overall aim of this project is to undertake an in-depth comprehensive study to identify the impediments and grey areas in optimising price discovery for assets in the process or resolution of distressed assets, within and outside the of the Insolvency and Bankruptcy Code 2016, with focus on secondary market for distressed assets, interim finance and litigation funding.

This survey relates to the litigation funding component of the study.

We are interested in your professional experience with and views on commercial litigation funding, to

- establish to what extent professionals in the industry are familiar with the concept of commercial litigation funding;
- establish to what extent litigation funding is being used;
- establish professional perception on the potential utility of litigation funding in insolvency;
- obtain the perspective of professionals in industry on the extent to which the current regulatory landscape would support or impede the enhanced used of commercial litigation funding.

The identity of survey participants will not be disclosed and participants will have the choice to not respond to specific questions.

## What does participation in this research involve?

Participation in the project is voluntary and involves anonymous completion of an online survey. # Do I have to take part in this research project?

Once you submit your survey, however, we are unable to remove your response as it will be impossible to identify your completed survey.

# What will happen to information about me?

All data collected or used is non-identifiable by the researchers. When the survey is closed to participants, the data will be taken down from the RedCAP survey instrument and stored on a secure, locked computer at the University of South Australia. The data will be stored for 5 years per the University's data storage requirements.

The data will be kept on Australian servers.

By signing the consent form you consent to the research team collecting and using information about/from you for the research project. Any information obtained in connection with this research project that can identify you will remain confidential. Information collected or used will be stored as non-identifiable.

Your information will only be used for the purpose of this research project and subsequent academic publications based on this project.

The information that the research team collect and use is information from online surveys. The data will be stored on Australian servers in electronic format.

The research results will be published by way of an Insolvency Law Academy research report.
